RESOLUTION NO. 12 – SERIES 2026

A RESOLUTION AUTHORIZING THE TOWN CLERK TO CANCEL THE 2026 REGULAR MUNICIPAL ELECTION AND DECLARING THE CANDIDATES ELECTED

WHEREAS the Town of Coal Creek is scheduled to conduct its regular municipal election in November 2026 for the purpose of electing members of the Board of Trustees; and

WHEREAS, pursuant to C.R.S. § 31-10-507 and applicable Town election provisions, a municipal election may be canceled when the only matter before the electors is the election of persons to office and, at the close of business on the sixty-fourth day before the election, there are not more candidates, including candidates filing affidavits of intent as write-in candidates, than offices to be filled; and

WHEREAS, the deadline for filing nomination petitions has passed; and

WHEREAS, as of the close of the applicable deadline for affidavits of intent for write-in candidates, the number of qualified candidates for the offices to be filled does not exceed the number of available offices; and

WHEREAS, there are no ballot questions or other matters requiring submission to the registered electors of the Town at the 2026 regular municipal election; and

WHEREAS, the Board of Trustees finds that the requirements for cancellation of the election have been satisfied and that conducting an election when the number of candidates does not exceed the number of offices to be filled would result in unnecessary expense to the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF COAL CREEK, COLORADO:

Section 1. Cancellation of Election.

The Town Clerk is hereby authorized and directed to cancel the Town of Coal Creek 2026 regular municipal election in accordance with C.R.S. § 31-10-507 and applicable Town ordinances.

Section 2. Candidates Declared Elected.

The following qualified candidates are hereby declared elected to the offices indicated, subject to the terms and requirements provided by law:

Board of Trustees:

Trustee: William Lackey 4 year term

Trustee: Leroy Kessler 4 year term

Trustee: Dennis Cox 4 year term

Section 3. Notice of Cancellation.

The Town Clerk is authorized and directed to provide notice of the cancellation of the election as required by law, including posting and publication as applicable.

Section 4. Effective Date.

This Resolution shall take effect immediately upon adoption.
